Plaintiff engaged in the activities alleged herein and/or were in some manner responsible for the injuries or damages to the Plaintiff which was a proximate cause of injuries or damages to the

Plaintiff and that their "true names, identities, capacity, activities and/or responsibilities" are

presently unknown to the Plaintiff or her attorney. To ascertain the full names and identities of

PROFIT" CORPORATIONS 1-10 and ROE GOVERNMENTAL ENTITIES 1-10, Plaintiff's

counsel has investigated the facts alleged herein through *inter alia* interview of the Plaintiff and

the records and files submitted by the Plaintiff. When the true names and capacities are

ascertained, through appropriate discovery, the Plaintiff shall move to amend this Complaint to

state the true names.

II. JURISDICTION

4. Plaintiff incorporates as if realleged, paragraphs 1 through 3, herein.
5. This Complaint is brought pursuant to Sections 603-21.5(a)(3) and 663-1, Hawaii Revised Statutes (hereinafter referred to as "HRS").

III. FACTS

6. Plaintiff incorporates as if realleged, paragraphs 1 through 7, herein.
7. At all times relevant, the Plaintiff has been engaged managing and publishing an online new journal, Big Island Chronicle and has written articles as an investigative journalist, edited content, manage the website and does advertising.
8. In November of 2011, Plaintiff was doing background research on cyberharassment and cyberbullying.
9. In the course of her research she encountered and interviewed Kathleen Hancock about her experience of being a victim of cyberharassment and cyberbullying.

10. The Defendant became aware of the Plaintiff's research and discussions with

Kathleen Hancock.

11. On or about November 5, 2011, the Defendant posted a warning to the Plaintiff

online on the Puna Online Message Board:

Ah..ha...Hey **Tiff**,

is this a warm-up for what's to come when it becomes time to trash Tom Lackey?
If it is be careful I can be a formidable foe. (Emphasis added)

12. On or about November 15, 2011, Defendant launched his campaign of publishing

highly offensive and defamatory cartoons that he drew and published online.

13. On or about November 15, 2011, Defendant published online, the first of a series of defamatory, pornographic cartoons that specifically identifies the Plaintiff as one of the individuals depicted in the offensive drawing. See, Exhibit "1," attached hereto, at 001 ("My name is Tiffany . . .").
- A. The cartoon specifically uses the name "Tiffany" and refers to the Plaintiff's research involving Kathleen Hancock. Id.
14. At all times stated herein, the Defendant used the Plaintiff's name and business, Big Island Chronicle, through a technique nicknamed as "tagging" which directs any internet inquiry of that name to his defamatory statements and depictions.
15. On or about November 15, 2011, the Plaintiff contacted the Defendant and asked him to stop his defamatory attack and remove the defamatory, pornographic cartoon. The Defendant responded, "Tiffany Edwards (Cunt) you can fuck off" and promised to publish more cartoons on his website.
16. On or about November 15, 2011, the Defendant published online specifically referring to the Plaintiff and also used the nickname "Tiff" referring to the Plaintiff and stated:
- I'm beginning to believe that the cartoon is much more mighty than the wordsmith. So all you asshole's can go and write a novel if you want. I will just draw another toon that speaks volumes and makes you look like the fools you are.
17. On or about November 16, 2011, the Defendant published another defamatory, pornographic cartoon that specifically identifies the Plaintiff as one of the individuals depicted in the offensive drawing and her research and investigative report on cyberharassment and cyberbullying. See, Exhibit "1," attached hereto, at 002 ("Well here we go again . . .").
18. On or about November 17, 2011, the Defendant published another defamatory,

pornographic cartoons that specifically identifies the Plaintiff as one of the individuals depicted in the offensive drawing and her research and investigative report on cyber harassment and cyberbullying. See, Exhibit "1," attached hereto, at 004 ("My name is Damon . . .").

19. On or about November 18, 2011, the Defendant published another defamatory, pornographic cartoon that specifically identifies the Plaintiff as one of the individuals depicted in the offensive drawing and her research and investigative report on cyberharassment and cyberbullying. See, Exhibit "1," attached hereto, at 005 ("I'm not trying to make you . . .").

20. On or about November 19, 2011, the Defendant published another defamatory, pornographic cartoon that specifically identifies the Plaintiff as one of the individuals depicted in the offensive drawing. See, Exhibit "1," attached hereto, at 006 ("Damon here . . .").

21. On or about November 20, 2011, the Defendant published another defamatory, pornographic cartoon that specifically identifies the Plaintiff as one of the individuals depicted in the offensive drawing. See, Exhibit "1," attached hereto, at 007 ("Look what Savu Savu . . .").

22. On or about November 20, 2011, the Defendant publicly taunted the Plaintiff and notified the public to expect another defamatory and pornographic cartoon:

That's not the point, the name that I gave my made-up facious character was named Tiffany, and in her personal code of ethic that is enough for her to get some recognition off my hard labor drawing toons. The spotlight is now on her and what she is going to do.

I have just drawn a new toon today of the Tiffany character that I'm sure will send her to the lawyers. I'm not sure just what she is trying to accomplish with this crap. Maybe her web site ain't getting enough reads and is using my talents to foster more readers to her site.

Tomorrow's [sic] toon is a hoot, it had me laughing while drawing it, and I can see the shit hitting the fan now.

29. On or about February 11, 2012, the Defendant republished another defamatory

cartoon depicting the Plaintiff, pregnant under the title, "News Woman to save the day" and

wrote:

Yep. Tiffany Edwards Hun is on a mission to "GET" Tom Lackey. This self-appointed "Newswoman" as she calls herself has also self-identified herself as a person in one of my cartoons. Can anyone really believe that, what a **Bimbo**. (Emphasis added)

See, Exhibit "1," attached hereto, at 018 ("New Woman to save the day")

30. On or about February 13, 2012, the Defendant published online a statement that in

relevant part, warning:

As long as Hunt keeps using my good name and continues to slander me I will not go away. Mrs. Hung you have a few friends that will cherish anything you say. The bottom line is that thousands are beginning to see you in a new light and it ain't so pretty.

31. On or about February 15, 2012, the Defendant published a cartoon that specifically

identifies the Plaintiff, and "tags" the Plaintiff's full name and "Big Island Chronicle" and mocks

the Plaintiff's unsuccessful efforts to obtain a Temporary Restraining Order against the

Defendant and criminal complaint:

Well accusations have been all over the internet and God finally had to step in. It is my hope that he does not file a criminal harassment against me like he may do against Savu Savu. I tink that I am OK because he has been guiding my pencil, but one never knows he may take a dislike to one of my toons and get a TRO "and" a criminal harassment complaint because he thinks that this cartoon is really him. Oh well, I guess that is just one of the perils of blogging.

See Exhibit "1," attached hereto, at 020 ("God")

32. On or about February 1, 2012, the Defendant published online a statement under the title, "Tiffany Edwards Hunt goes too far" which confirmed his intent in publishing the defamatory and pornographic cartoons and online defamatory statements:

I also told Tiffany Edwards Hunt that if she persisted to keep trying to "get the good" on The Lack that I am a pretty formidable foe.

33. That the Defendant has made blocked telephone calls to the Plaintiffs house, he has driven his vehicle past the Plaintiff and her family and the Defendant continues to publish his defamatory statements about the Plaintiff.

IV. CAUSES OF ACTION

A. COUNT I (Defamation, per se)

34. Plaintiff repeats and realleges the allegations contained in paragraphs 1 through 33, inclusive, and incorporates the same by reference as though set forth fully herein.

35. Defendant, published, disseminated and/or communicated and/or caused to be published, disseminated and/or communicated, and/or ratified and adopted, false and defamatory statements regarding the nature and subject of the Plaintiff and her business.

36. That the Defendant, published, disseminated and/or communicated and/or caused to be published, disseminated and/or communicated, and/or ratified and adopted, false and defamatory statements regarding the nature and subject of the Plaintiff's competency, professionalism and ability, in reckless disregard of the truth and despite knowing that the statements were untrue.

37. That the Defendant's statements regarding the Plaintiff were defamatory per se

because the defamatory statements, as previously alleged herein:

- a. Held the Plaintiff up to scorn and ridicule and to feelings of contempt or execration, impaired her in the enjoyment of society and injured those imperfect rights of friendly intercourse and mutual benevolence by falsely accusing her without sufficient factual basis; and/or,
- b. Imputed to the Plaintiff, an unfitness to perform the duties of her employment or which had a tendency to prejudice her in such employment.

38. That the Defendant lost and/or abused any qualified privilege which may have existed in making such false and erroneous statements by failing to exercise such a qualified privilege in a reasonable manner and proper purpose because: (a) the Defendant knew, had reason to believe, or should have known that, the defamatory statements regarding the Plaintiff were in fact untrue; and/or (b) that the Defendant knew, had reason to believe or should have known that the defamatory statements regarding the Plaintiff were taken out of context and

should have inquired further into the nature, substance and context of the alleged statements and stopped or clarified such communications; and/or (c) the Defendant had reason to believe or should have known that, the defamatory statements regarding the nature and subject of the Plaintiff were highly suspect and lacked credibility; and/or (d) that despite his knowledge of the lack of credibility and accuracy of the nature and subject of the allegations, the Defendant caused to be published, communicated and disseminated, ratified and adopted, the defamatory

statements about the Plaintiff, to the public.

39. That the Defendant lost and/or abused any qualified privilege which may have existed in making such false and erroneous statements by failing to exercise any qualified

privilege in a reasonable manner and proper purpose because: (a) excessive publication as set forth previously herein; and/or (b) used the defamatory statements for an improper purpose by attempting to ruin the Plaintiff's reputation among her friends, co-workers, family, and community; and/or (c) the Defendant lacked belief or grounds for belief in the truth of the defamatory statements regarding the nature and subject of the Plaintiff.

40. As a direct, proximate and foreseeable result of Defendant's actions as set forth above, the Plaintiff has sustained special and general damages in amounts to be proved at trial including but not limited to past and future lost wages, employees' benefits, loss of business opportunities, injury to reputation, mental and emotional distress, anguish and humiliation.

41. That the Defendant's actions were wilful, wanton, reckless or done with conscious indifference to the consequences so as to entitle the Plaintiff to an award of punitive damages against the Defendant in amounts to be proved at trial.

B. COUNT II (Defamation, negligence)

42. Plaintiff repeats and realleges the allegations contained in paragraphs 1 through 41, inclusive, and incorporates the same by reference as though set forth fully herein.

43. That the images, cartoons and written statements concerning the Plaintiff at all times mentioned above, were false and defamatory.

44. That the Defendant knowingly and intentionally published his false and defamatory statements about the Plaintiff.

45. That the Defendant published and continued to publish false and defamatory statements about the Plaintiff, despite being asked by the Plaintiff to cease and desist.

46. That if the Plaintiff is found to be a "public figure", the Defendant published and

continued to publish false and defamatory statements about the Plaintiff with actual malice, in order to retaliate against her, ruin her business and/or hold her up to ridicule in the community. 47. That the false and defamatory statements about the Plaintiff, were patently offensive, and actionable.

C. COUNT III (Negligent Infliction of Emotional Distress)

48. Plaintiff repeats and realleges the allegations contained in paragraphs 1 through 47, inclusive, and incorporates the same by reference as though set forth fully herein.

49. That the Plaintiff, or any other reasonable person, was and is, unable to adequately cope with the mental and emotional stress caused by the Defendant's conduct, as described herein, collectively and individually.

50. That the Defendant's actions as alleged herein in defaming her, caused her to suffer severe emotional pain, suffering, inconvenience, loss of business opportunities, mental anguish, loss of enjoyment of life, and other nonpecuniary losses as a direct result of Defendant's negligence.

D. COUNT IV (Injunctive Relief)

51. Plaintiff incorporates as if realleged, paragraphs 1 through 50, herein.

52. Absent the grant of an order for permanent injunction, the Plaintiff, has no adequate remedy at law to prevent the Defendant from continuing to publish defamatory and pornographic images and statements about her.

53. Plaintiff will likely prevail on the merits of the claims that the Plaintiff is not a public figure, that Defendant defamed, per se, or in the alternative, negligently defamed, the Plaintiff, through the publication of defamatory and pornographic images and statements about her.

54. The Plaintiff will suffer irreparable damage resulting from Defendant's continued misconduct including but not limited to maintaining her business operation, Big Island Chronicle, due to loss of advertisers.

55. The public interest supports granting injunctive relief because the defamatory and pornographic images that the Defendant uses to defame the Plaintiff.

56. Plaintiff is entitled to injunctive relief enjoining Defendant from publishing further defamatory and pornographic images and statements about the Plaintiff and to have the Defendant stopped from contacting the Plaintiff and her family..

V. PRAYER FOR RELIEF

57. Wherefore, Plaintiff prays that this Court:

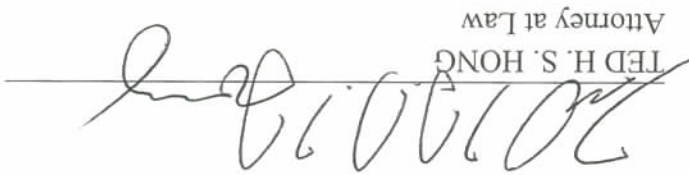
a. As a direct and proximate result of Defendant's actions, Plaintiff has suffered and will continue to suffer emotional distress, consisting of outrage, shock and humiliation, reasonably occurring and likely to occur based on harassment and retaliation she experienced and the Defendant's pattern and practice of defaming the Plaintiff and her business; and she has suffered and will continue to suffer a loss of earnings and other business opportunities and job opportunities. Plaintiff is thereby entitled to general and compensatory damages in amounts to be proven at trial.

b. Plaintiff is informed and believes, and based thereon alleges, that the outrageous conduct of Defendant described above was malicious and oppressive, and done with a conscious disregard of Plaintiff's rights, and with the intent to injure Plaintiff, the Plaintiff is entitled to punitive damages from Defendant.

- c. Issue an order requiring Defendant to stop publishing any further defamatory, pornographic images and statements about the Plaintiff and her family and bar the Defendant from contacting the Plaintiff and her family.
- d. Award Plaintiff compensatory damages for her emotional suffering and related medical and therapeutic expenses in the amount to be proved at trial.
- e. Award Plaintiff punitive damages in the amount to be proved at trial.
- f. Award Plaintiff attorney's fees, including expert witness fees.
- g. Award Plaintiff costs, pre and post judgment interest, and such other relief as this Court may deem just and proper.

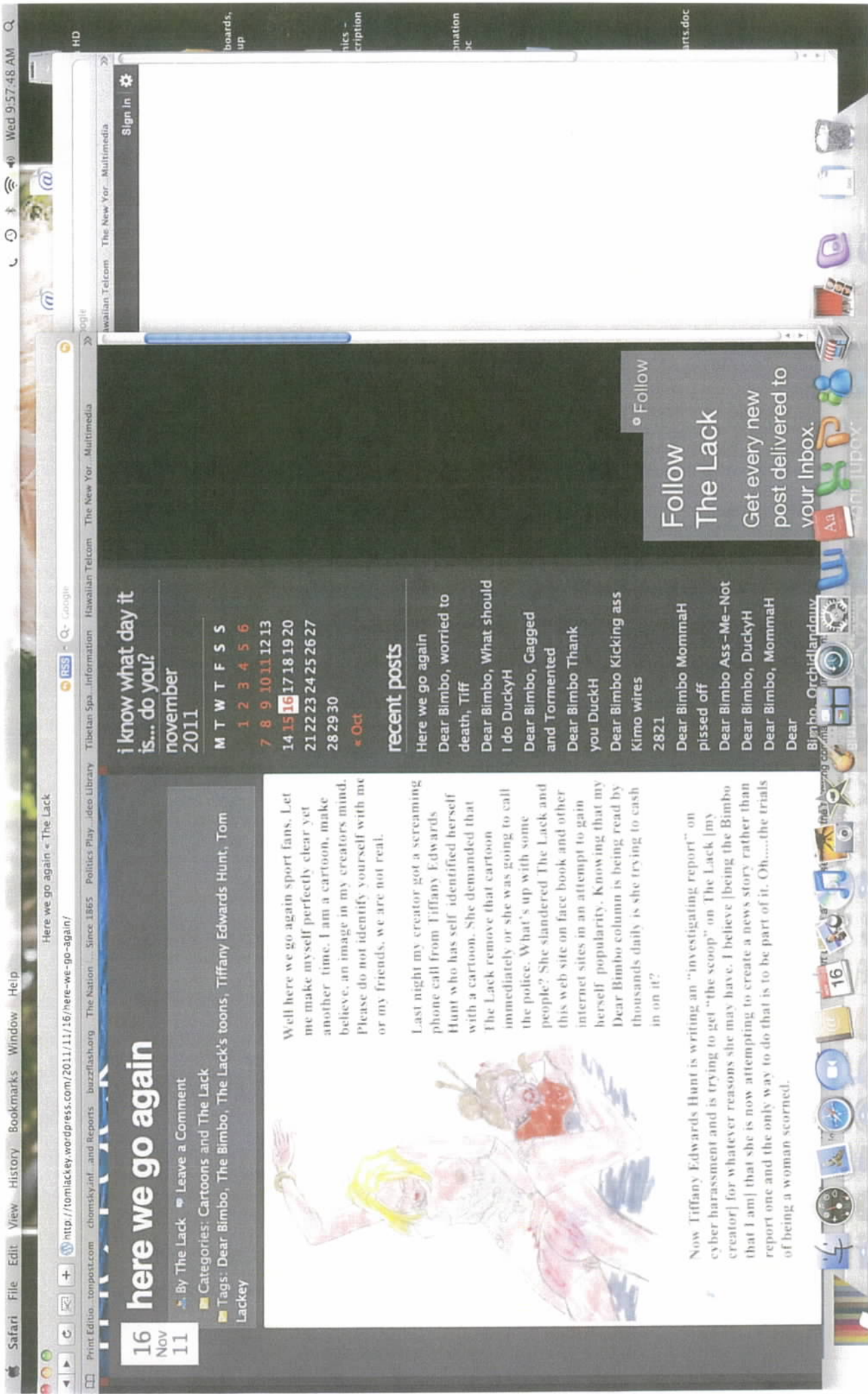
